The Project includes the following Work:

- Remove existing ± 24 ' Single Span Bridge with 4-48" CMP Culverts.
- Install 2 66" Precast RCP @ 40' and 4 Precast Flared End Sections.
- Additional items as set forth in the Contract Documents.
